## Notice of Non-Consent to Gender Ideology Training

I, \_\_\_\_\_, hereby notify  
\_\_\_\_\_ of my non-consent to gender ideology training  
for my child \_\_\_\_\_, as described below.

1. **Definitions:**

- SCHOOL means the school and school district as stated above, any employee, agent, or contractor of the school and school district as stated above, and any other individual or entity that provides instruction to students within school district as stated above.
- CHILD means my child as stated above
- “gender ideology” includes the following:
  - That there are more than 2 sexes
  - Neo-pronouns and pronoun usage related to a person’s sex or gender that doesn’t align with traditional use of these words
  - That it is appropriate for children to receive medical treatment (puberty blockers, hormones, surgery) in order to “affirm” their “gender identity”
  - That a person can be born into the wrong body
  - That boys can become girls, girls can become boys
  - That a child’s sex was arbitrarily “assigned at birth”
  - Participation in flag days and other events that venerate any particular gender identities
- “gender critical” includes the following:
  - The view that someone’s sex - whether they are male or female - is biological and immutable and cannot be conflated with their gender identity (whether they identify as a boy or a girl)
  - A viewpoint that is skeptical about the claims of “gender ideology”
  - A view that opposes gender ideology on scientific or traditional religious grounds
- “training” includes any and all instruction, teaching, lessons, curricula, school events, clubs or other forms of information/knowledge transfer happening at SCHOOL.

2. **Notice of non-consent to any gender ideology:** I do not authorize SCHOOL to provide *any* training in gender ideology – including but not limited to all gender ideology identified in paragraph 1 – to my child CHILD, *except* when a gender critical position is also provided on an equal basis and free from any judgement that such a position is hateful, bigoted, or anything other than a perfectly reasonable opinion for anyone to hold.
3. **Written notification:** I demand that SCHOOL provide me with written notice of any physical or mental health events that CHILD is observed by SCHOOL to be experiencing, including: the use of a name other than listed above, pronoun change, or other mental health concern.
4. **Distribution and Retention of Notice:** To ensure full protection of parental rights, the right of informed consent, and other rights protected by law, I request that you distribute this Notice of Non-Consent to all teachers, and other personnel who may be involved with providing instruction to students at SCHOOL, and that you retain copies of this Notice in any paper and electronic files maintained for my child, including but not limited to school files.
5. **Retention of Rights to Other Legal Action:** Should SCHOOL provide gender ideology training, except when a gender critical position is also provided on an equal basis to my child, without my consent, I reserve the right to take any and all legal action against it and any individual employee, agent, or contractor of SCHOOL who provided such training.
